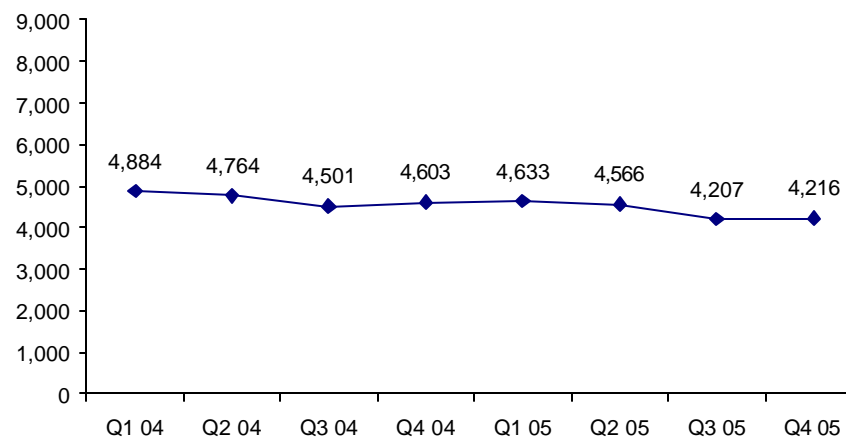
A screening determination on an incoming report is made by State Central Intake (SCI).

Reasons for non-acceptance may include:

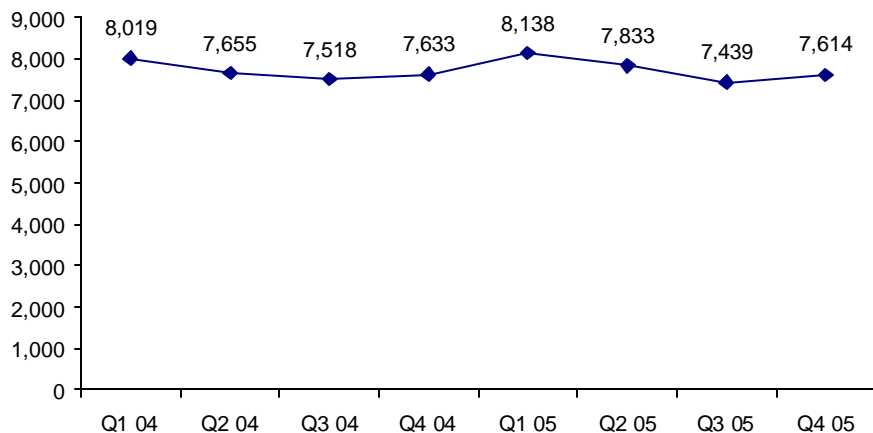
- No specific allegation/risk of abuse/neglect.
- Insufficient information to investigate.
- Referral to another agency.
- Perpetrator is non-caretaker/out-of-home.
- Referral to law enforcement.
- Does not meet sufficiency screen criteria.

Once accepted, the PS report is assigned to the appropriate county office for investigation.

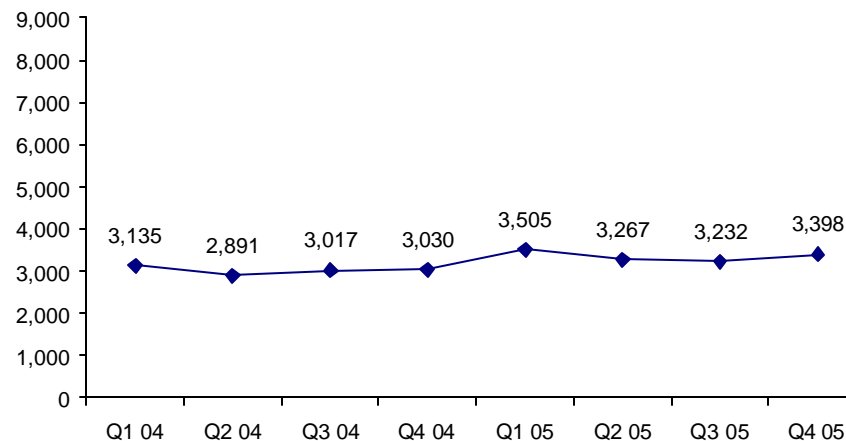
Accepted Reports

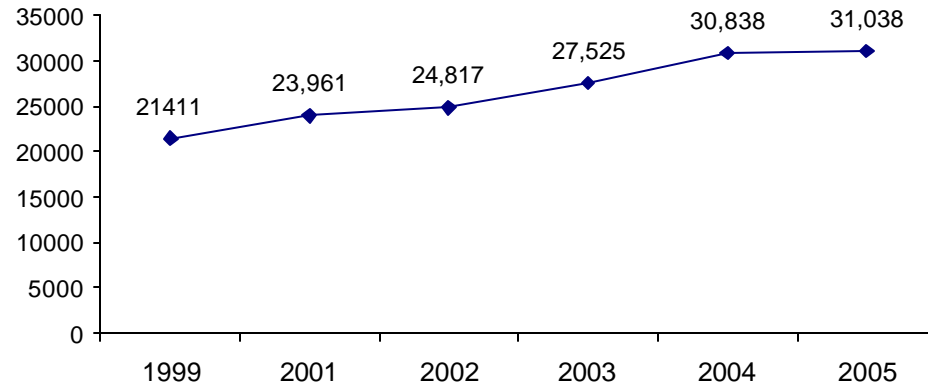

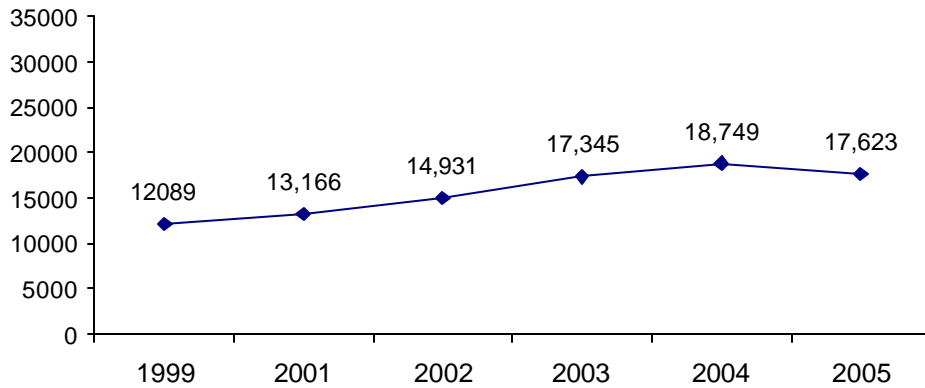

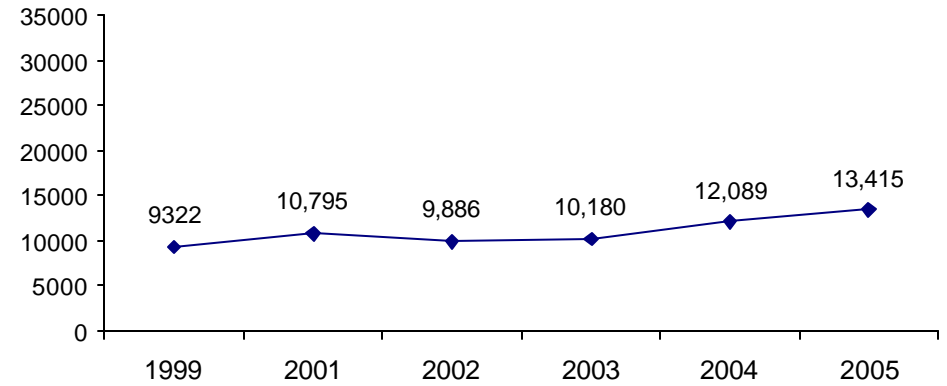
Total Reports

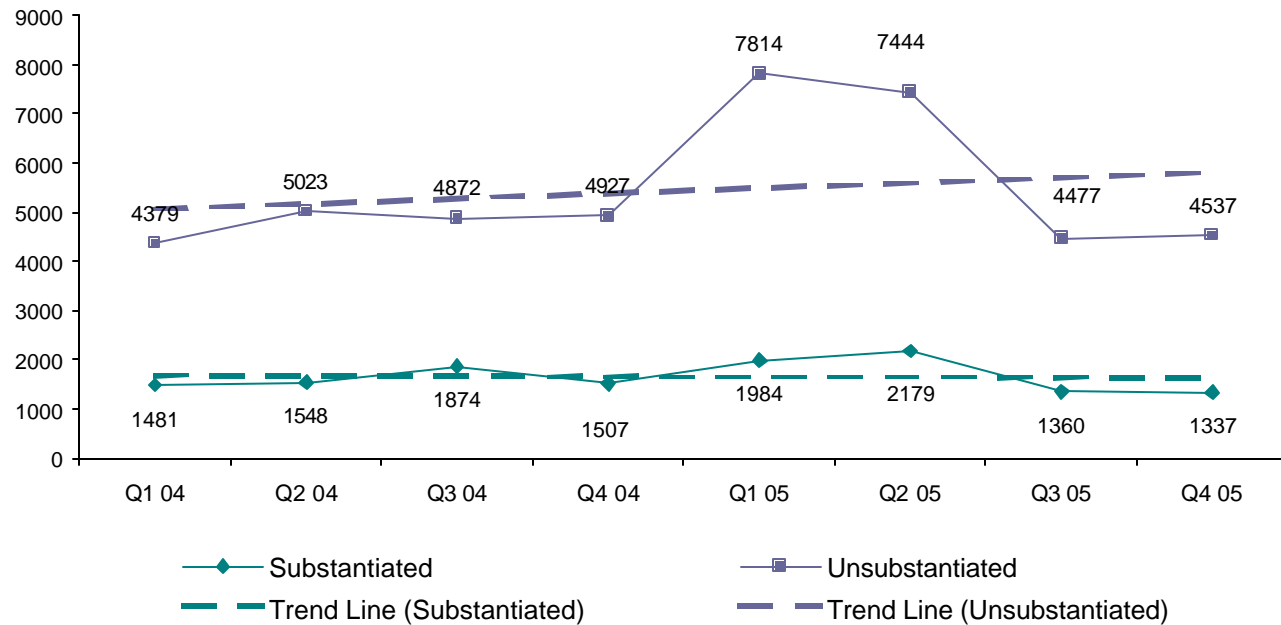

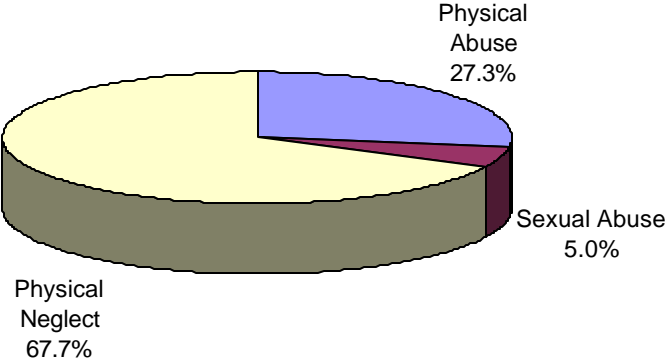

Annual 2005



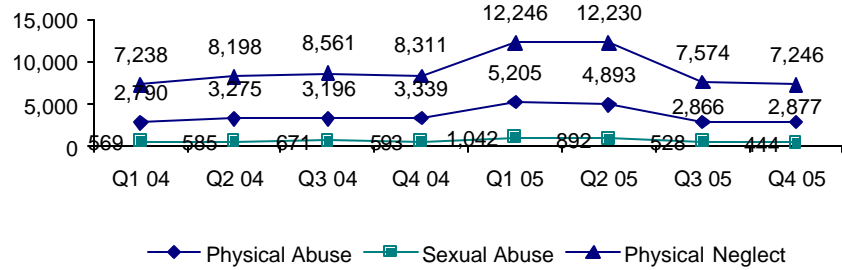

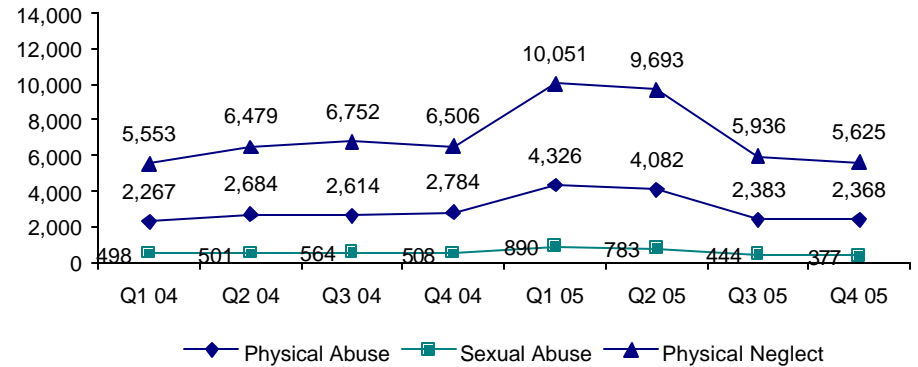

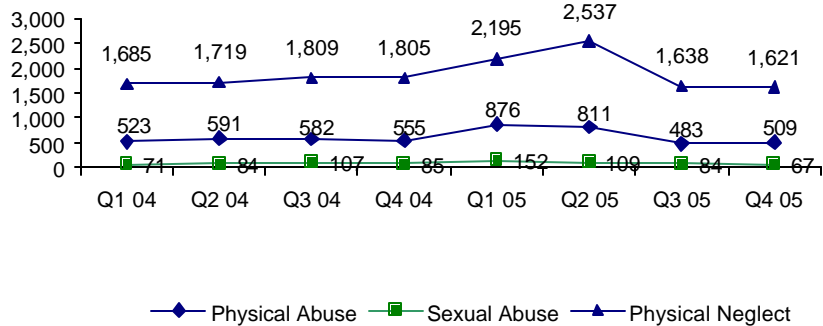
Total Allegations



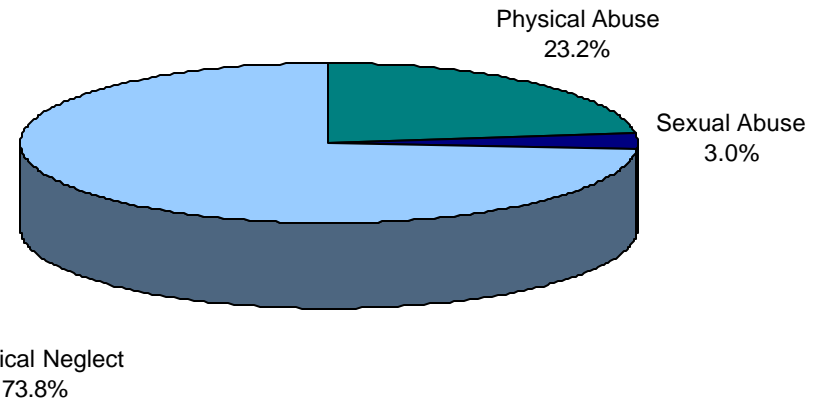
Unsubstantiated Allegations

Percent of Substantiated Allegations 4th Qtr 2005



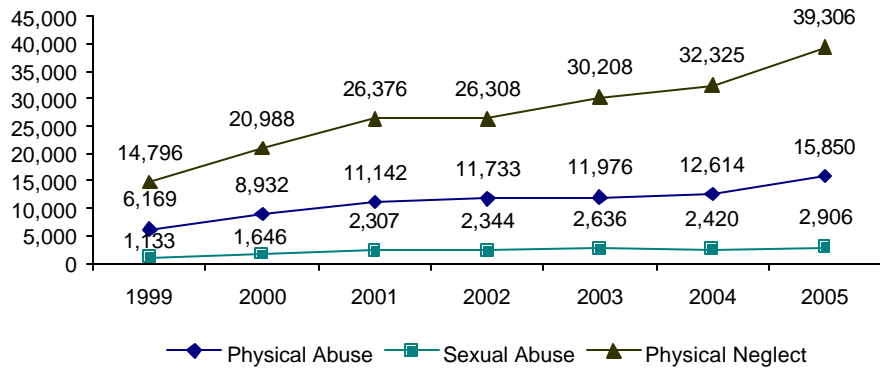

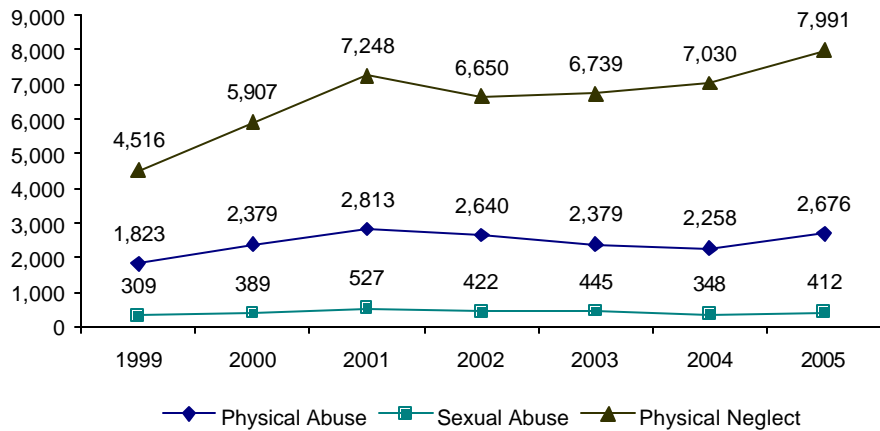

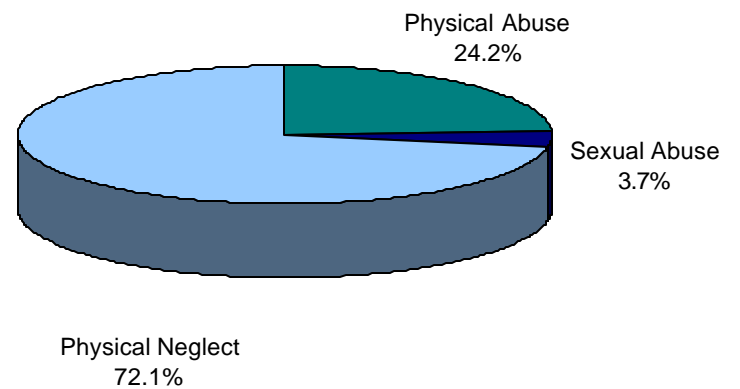
Unsubstantiated Allegations

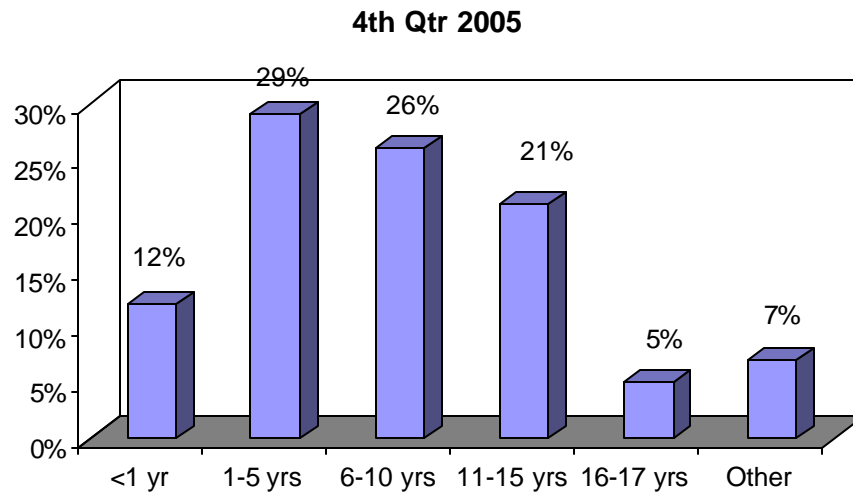


Percent of Substantiated Allegations Annual 2005

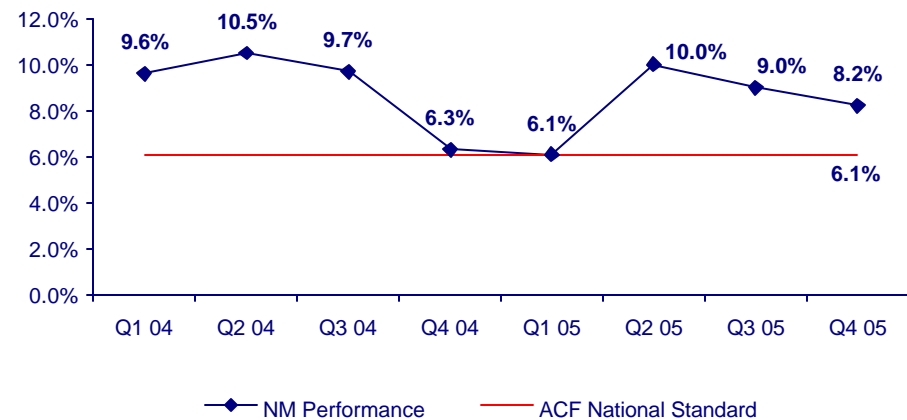

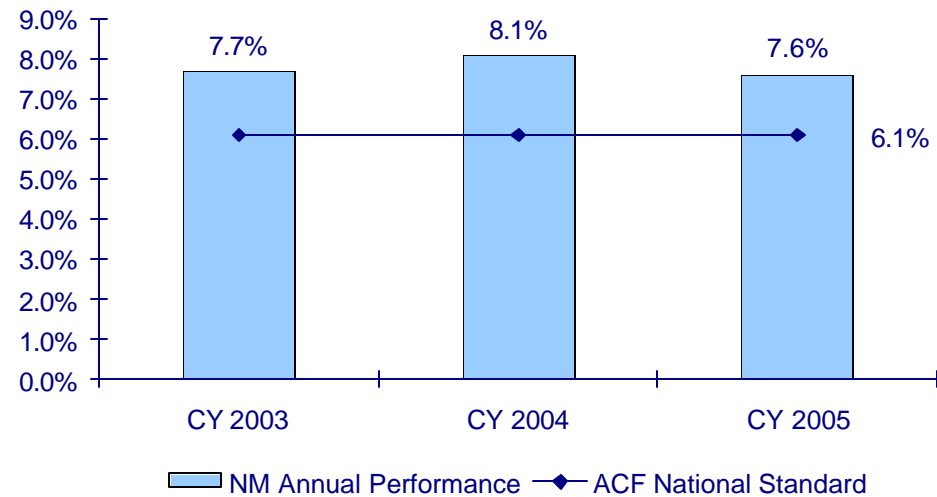

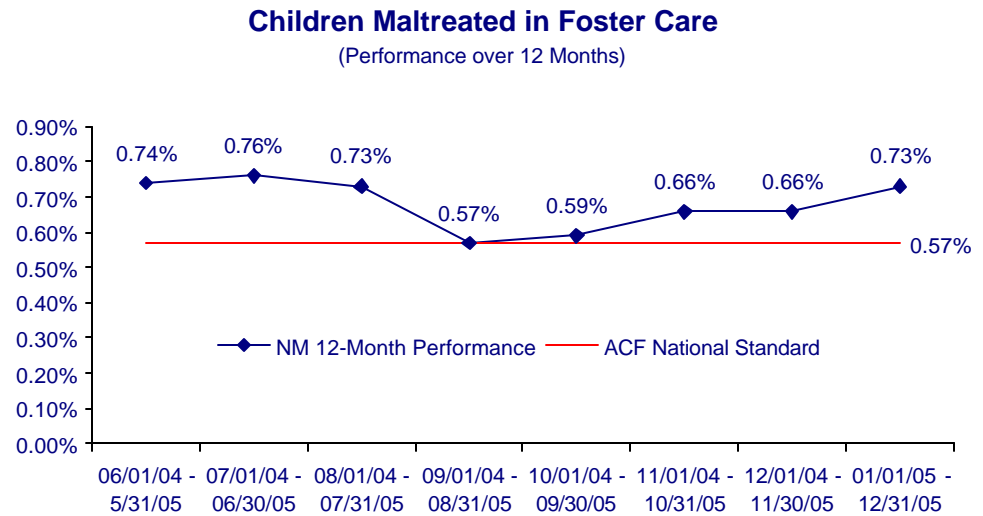

The national standard states that “no more than 0.57% of all children who were in foster care during the reporting period will be subjects of substantiated maltreatment by a foster parent or facility staff”.

Quarterly data has proven to be unreliable in tracking this standard, due primarily to the length of time between receipt of a report and substantiation/unsubstantiation classification of the allegations. The end result is that a number of maltreatment incidents may **not** be included on quarterly reports, resulting in underreporting of the true incidence rate of maltreatment in foster care.

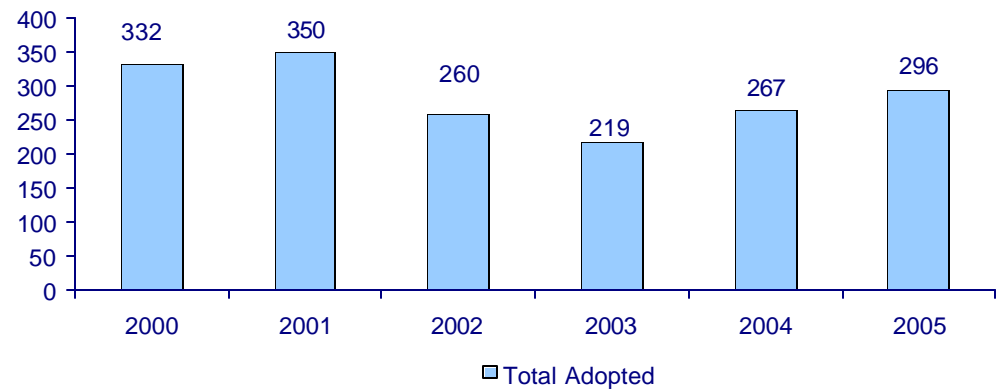

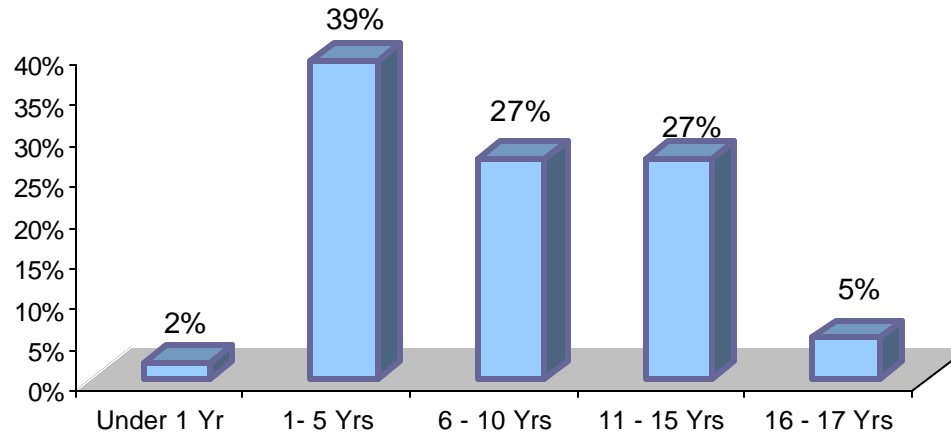

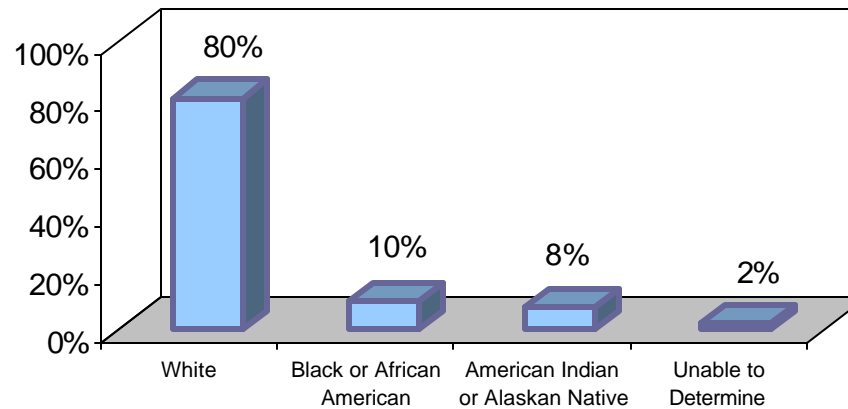

The average length of custody for children who have been freed and are waiting for adoption is 34.3 months. This figure was calculated by counting the days between custody and December 31, 2005.

Legal Statistics

During the fourth quarter of 2005, 754 children had “adoption” as a permanency goal. As of December 31, 2005, 365 children were legally freed to be adopted. Of those legally freed, 95 children were in adoptive family homes and has an adoptive agreement signed and in effect.

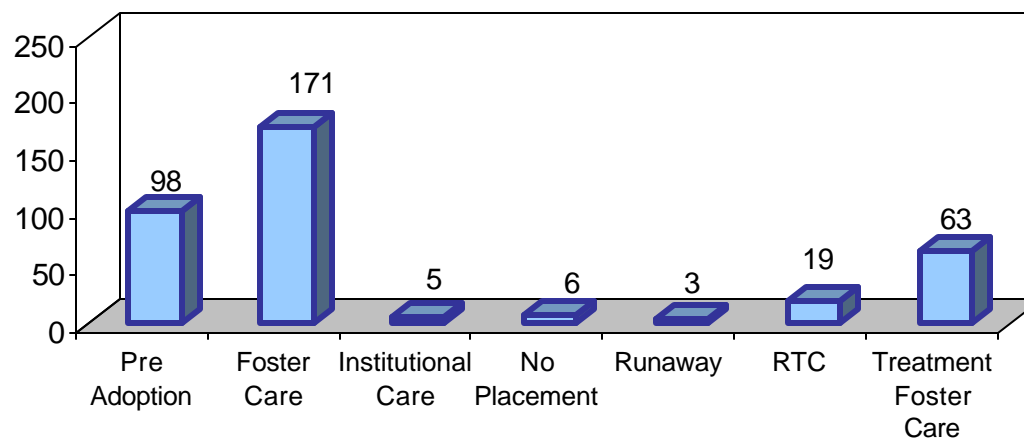

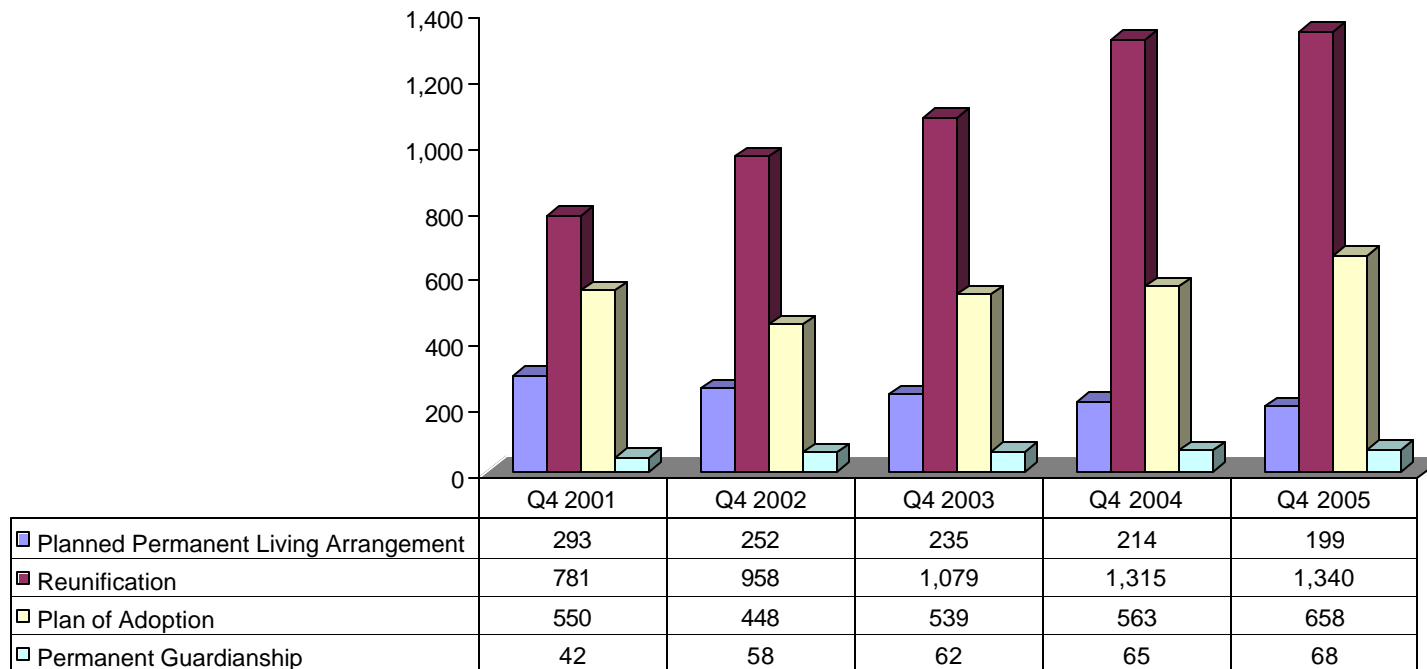

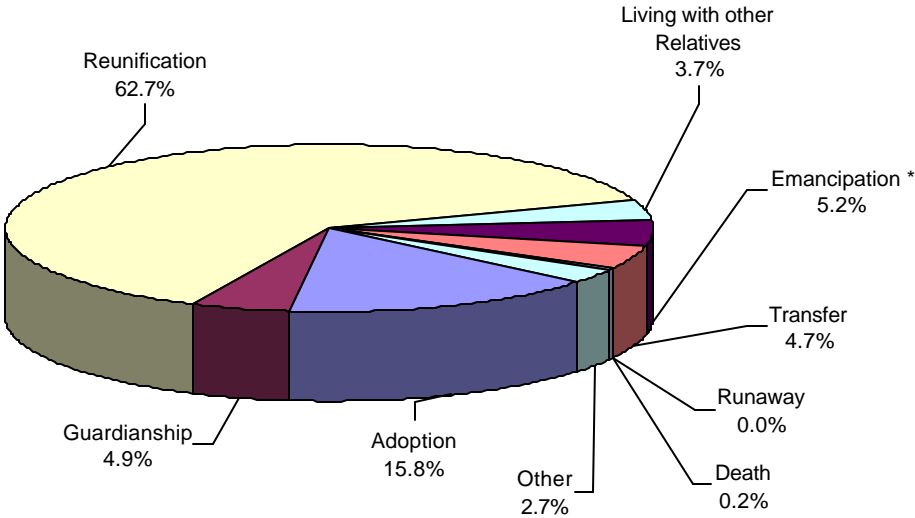

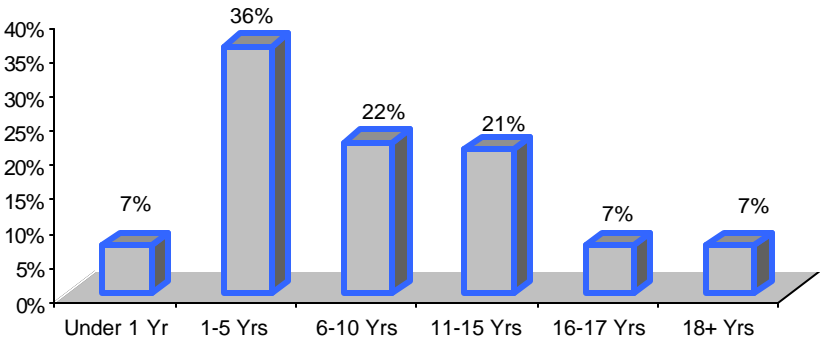

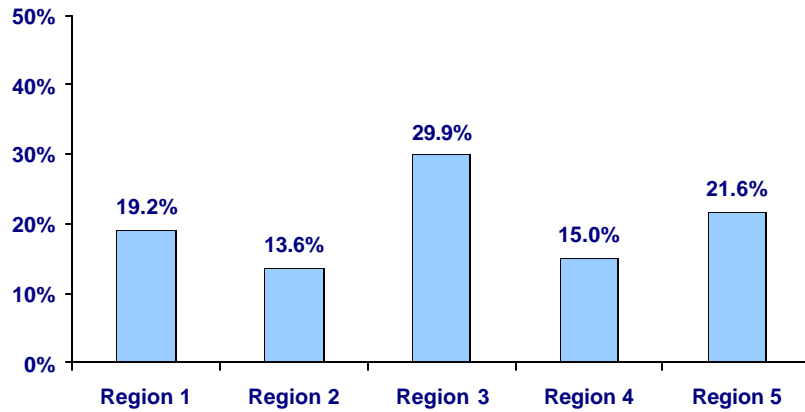

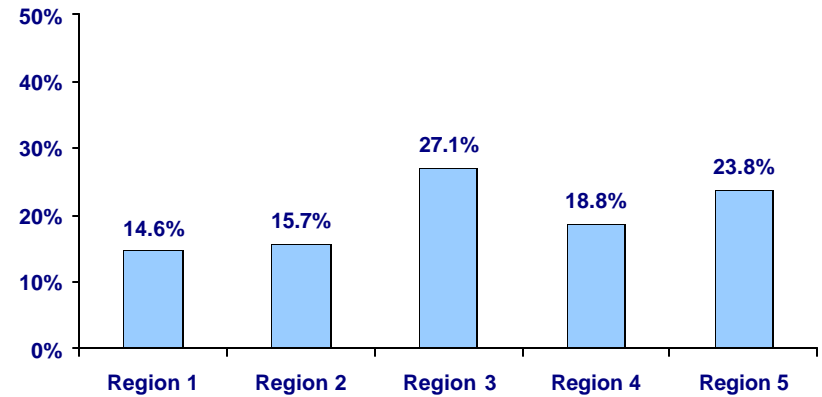

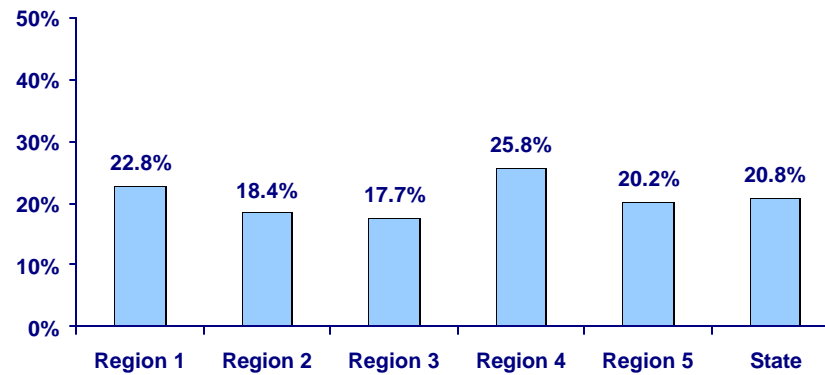

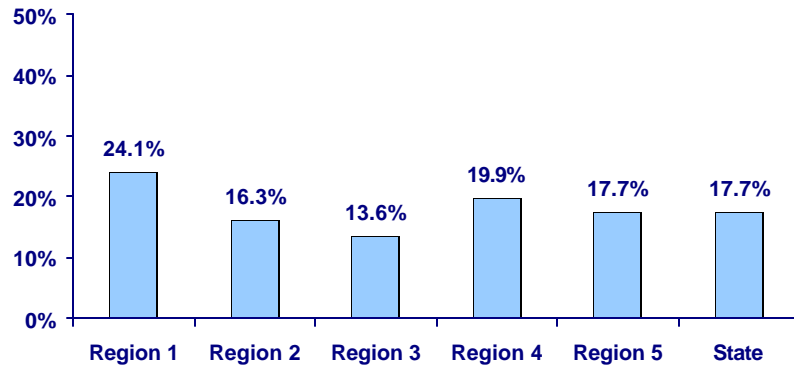
Total Substantiated Allegations



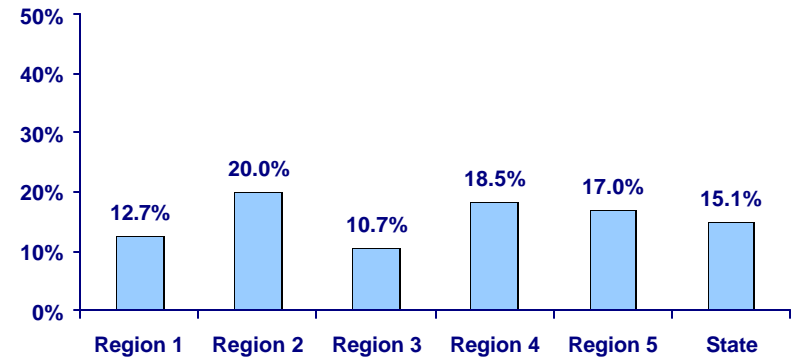

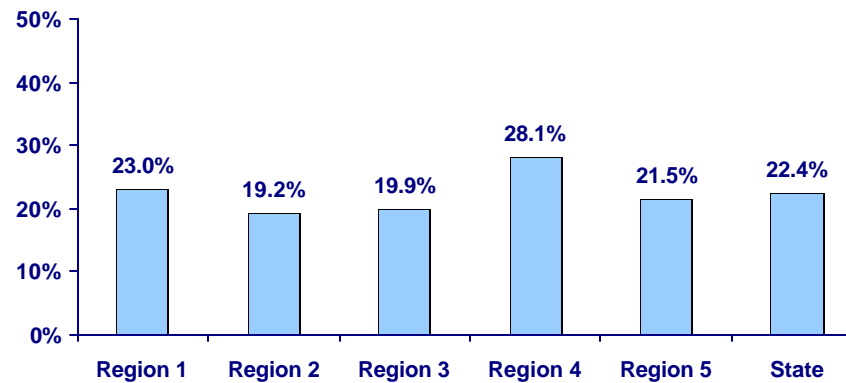
Substantiated Physical Abuse



Substantiated Sexual Abuse



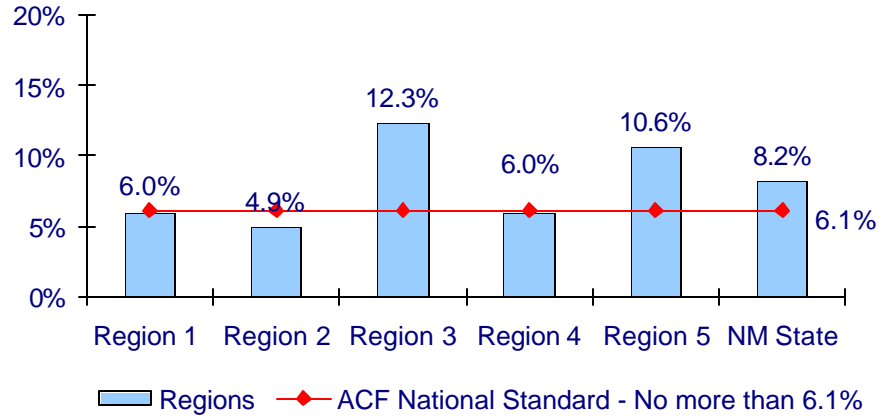

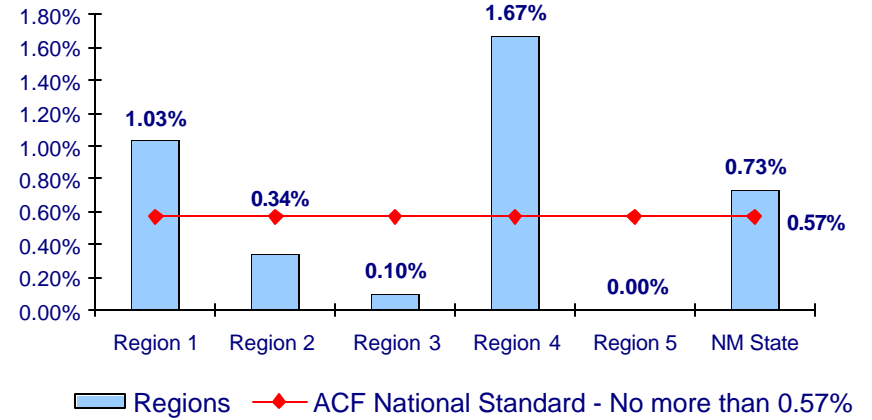

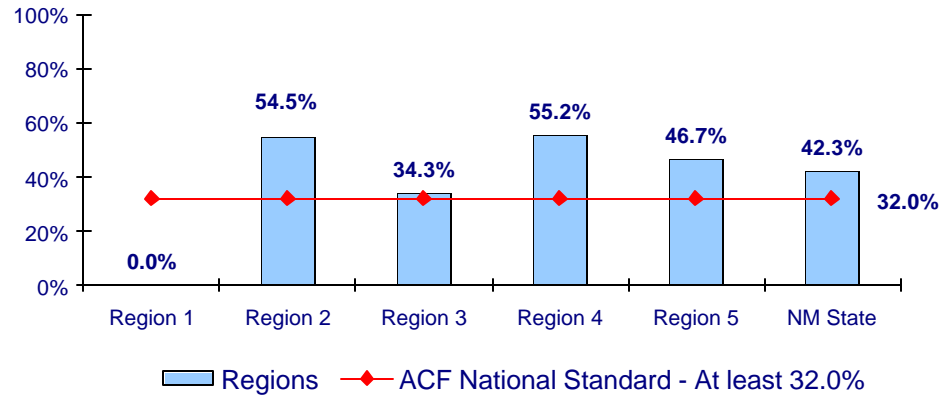
Recurrence of Maltreatment with 6 Months of a Previously Substantiated Report



Children Maltreated in Foster Care (Performance over 12 months)



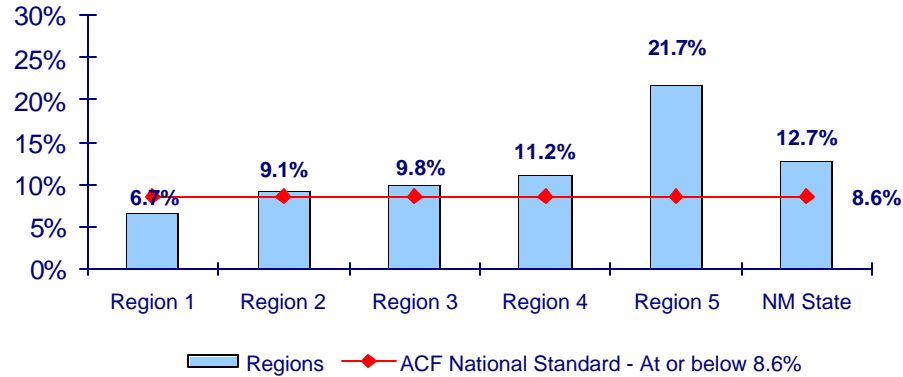
Children With a Finalized Adoption Within 24 Months of Entry into Care



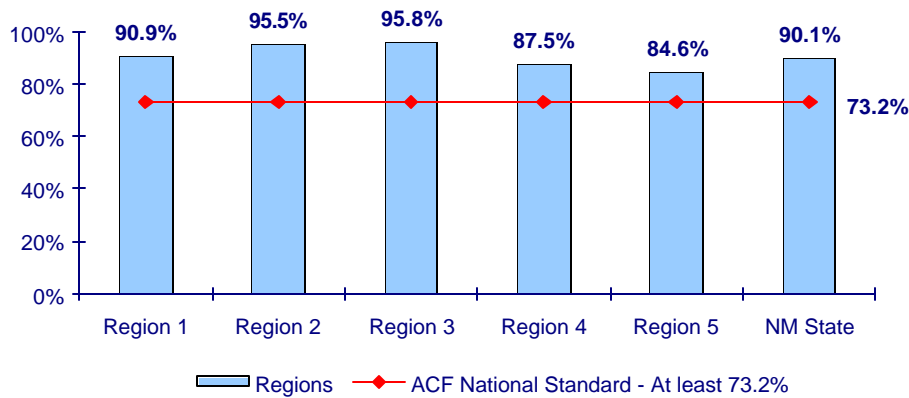
